

# **Professional Mentorship**

NEKC has been in conversation with Dr. Gentzon Hall to potentially expand NEKC's professional development and mentorship programs. Dr. Hall is an esteemed nephrologist at Duke University School of Medicine, as well as director of GlomCon Foundation's Mentored Internship Program in Nephrology (MIPiN). NEKC is actively working to develop professional development programs for underrepresented nephrologists across the country.

#### **Social Media Video**

As part of NEKC's effort to raise awareness of the Kidney PATIENT Act in the month of December, Dr. Janice Desir lent her voice to discuss a recent study published in the Clinical Journal of the American Society of Nephrology (CJASN). In the video, Dr. Desir highlighted the unintended consequences of bundling calcimimetics into the ESRD payment system and how the same policy decision will impact kidney patients who rely on PLTs. The findings revealed significant disruptions in patient access to these medications, increased delays in treatment, and diminished care quality, underscoring the need for a cautious, data-driven approach to policy changes. The video is being shared on NMQF and NEKC social media channels.



## **Member Spotlight: Dr. Desir**



In addition to her leadership with NEKC, Dr. Janice Desir is an accomplished physician in the Bronx, NY, where she serves as a nephrologist for both Kidney Medical Associates and Saint Barnabas Hospital. Additionally, she currently leads a team of 14 physicians in performing utilization reviews for hospitals and doctors in order to address denials by insurance providers, preventing long delays in payments and millions of dollars in potential losses for clients.

Dr. Desir's dedication and expertise have been instrumental in driving the success of our recent projects, especially in relation to advocating on behalf of the Kidney PATIENT Act.
