

We kicked off our engagement efforts with a meeting in NYC at the NMA in August, followed by our participation in the Kidney Community Health Equity Summit in September. These events set the stage for impactful collaborations and growing our membership.



#### **NEKC in the Community**

NEKC has been actively engaging in the community and advocacy work. Here are some highlights of our recent activities:

- NEKC hosted a webinar on September 6th featuring NEKC co-chairs, Drs. Sandra Gadson and Randall Maxey, as well other distinguished experts in the legislative, policy and medical fields to discuss the Kidney PATIENT Act and the importance of pushing patient-centered policies.

- Attending a health fair in Brooklyn, hosted by Congressman Hakeem Jeffries, to provide kidney disease-related resources to the community.

# Update on the Kidney PATIENT Act

The Kidney PATIENT Act continues to be a major focus of NEKC's advocacy work. Our efforts include direct engagement with policymakers and mobilizing our network to support this crucial legislation.

Congresswoman Maxine Waters (D-CA) is now a co-sponsor on the bill, including 11 other Congressional Democrats as of October 25, 2024.

We have prepared a comprehensive one-pager outlining the Kidney PATIENT Act's benefits and impact, which will be made available on our newly launched website. We encourage all members to review these resources and join our advocacy campaign.
